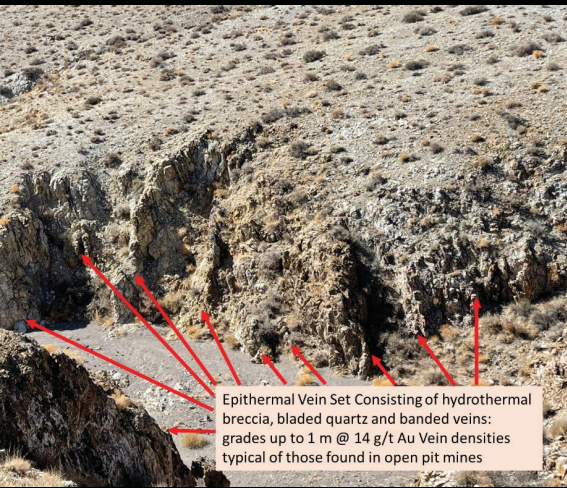
### Hot Springs Range

- World class deposit potential
- Analogue to Twin Creeks and Turquoise Ridge mines totalling 19mm oz but never before drilled
- Parallel trend 15km from 42mm oz Getchell Trend with several analogous features
- Planned drilling in 2023



### Weepah

- Located in the prolific Walker Lane Trend (total endowment of 80mm oz of Au and 700mm oz of Ag)
- Past producer of 117k oz Au
- Area consolidated for first time with up to 2km extension between West Pit and East Zone – past intercepts up to 17 g/t Au and recent samples of up to 60 g/t Au
- Planned drilling in 2023



### Gilbert South

- Located in Walker Lane Trend
- Multi-km gold system identified with abundant gold at surface with ideal conditions for bonanza style veins at depth – samples of up to 31 g/t Au
- Has had historical drilling
- Planned drilling in 2023



### Spanish Moon

- Analogue to Round Mountain with multiple Au and Ag targets; last historical drill intercepts of 13.5m of 7.6 g/t Au never previously followed up
- Located 13km from 23mm oz Kinross Round Mountain
- District property was a past producer of 200k oz high grade Ag
- Geophysics confirms target structures at Round Mountain analogue within its Spanish Moon District.
